Restriction of Hazardous Substances (RoHS) Update

Dear Madam, Sir,

Signify is committed to supplying products compliant with relevant laws, rules and obligations that relevant governmental bodies impose. In Great Britain and Northern Ireland, the Restriction of the Use of Certain Hazardous Substances in Electrical and Electronic Equipment Regulations 2012 (as amended) are the underpinning legislation. However, there are differences in how they apply in Great Britain and Northern Ireland, and the UK Government website can provide more details. https://www.gov.uk/guidance/rohs-compliance-and-guidance

One of the substances under RoHS is Mercury, which is used in our conventional portfolio. Whilst the UK still follows European Directive RoHS Directive 2011/65/EU, Great Britain operates its own exemptions system, independent of the EU exemptions system. In January 2023, the latest RoHS exemptions were published by UK Government, which brings the

following consequences for our Conventional Lamps Business and is unaligned with the EU on some banning dates.

Exemptions for CFL-ni and TL Fluorescent tubes will expire, which means a ban on placing the products on the Europe/UK market after the relevant expiry dates. The timelines are found in the below Appendix.

It is essential to know that the date for banning many of the lamps in the UK was moved to 2024 at very short notice meaning many of the lamps will become obsolete from our range before the official UK banning date as final production had already been made based on previous information from UK Government that the ban would be introduced in February 2023. This is now one year later than the EU date. Please check for availability at time of order.

After the expiry dates in 2024, any products in the UK can continue to be sold from Signify Commercial Warehouses, provided that the lamps have been delivered to these warehouses (put on the market) before the official expiry dates. Further distribution and onward sale in UK are allowed until available stock is depleted. Furthermore, where remaining stocks allow, we will support you with last time buy of our conventional lamps for an easy transition.
